

### Introduction

Since the incorporation of Local Government Information Technology in South Australia (LGITSA) in June 2015, the LGITSA has become an established leader and advocate on behalf of information technology and information management professionals working within the local government sector in South Australia.

LGITSA has established a strong membership base and business relations with organisations that can help deliver better outcomes for members and their councils.

In its sponsors LGITSA values:

### 2018/2019 Sponsorship

Platinum sponsorship for 2018/2019 is \$11,000 ex GST and Gold sponsorship is \$5,500 ex GST per annum.

The Sponsorship Value Proposition remains based on two (2) events per annum (a two day conference and awards event in October and a one day workshop in May), plus an end of year networking event.

A maximum of three (3) Platinum sponsors will be appointed. Only one Platinum sponsor will be selected from each service/product area based on the primary product/service offered by the sponsor. A maximum of twenty (20) Gold sponsors will be appointed.

Sponsors are selected based on their financial contribution, provision of other support items to increase the value of the LGIT SA to members and relevance of the sponsor to Local Government IT in SA and, for Platinum sponsors, the uniqueness of their product/service offering relative to other sponsors.

### Terms and Conditions

- The LGITSA board's decision is final, and the board reserves the right to accept or reject any application.
- The sponsor agreement will be terminated if payment is not made prior to 10 July of the sponsorship year, in a lump sum in Australian Dollars.
- Sponsorship is valid for the financial year, and withdrawals are not eligible for refund.
- Sponsors must maintain their own insurance for events and indemnify LGITSA Incorporated from any cost, claim, liability and expense associated with sponsorship and associated events.

### How to apply:

Incumbent sponsors of LGITSA have the opportunity to commit to renewing their sponsorships by returning the completed 'LGITSA 2018/2019 Sponsorship Application Form' by 31 May 2018, after which time any unfilled sponsorship slots will be available to new sponsors.

LGITSA reserves the right to deny renewal, should the sponsor be considered to be acting outside the values of LGITSA.
